KS 90

Description

The industrial controller type KS 90 is suitable for individual closed-loop control circuits and for automating industrial processes. The KS 90 is designed as a limit-value switching controller for use in conjunction with a compact-type conductivity electrode LRGT 16-1 and type approved by TÜV (German Technical Supervisory Association) and EC.

A self-tuning feature is included as standard. The configuration and parameterization data are stored in an EEPROM. The user-friendly two-line alphanumeric LED display is menu driven and enables easy configuration and parameterization of the universal controller KS 90 on site and in accordance with the respective operating conditions and requirements.

Design

Plug-in controller in accordance with DIN 43700 for installation in control cabinets and panels. Cut-out size $45^{+0.6}$ x $92^{+0.8}$.

Wiring via flat-pin terminals, 1 x 6.3 or 2 x 2.8 mm to DIN 46244.

For lines $\leq 2.5 \text{ mm}^2$.




